Meetings were conducted with various sections of students – II, III year and IV year students during the beginning of the semester, by Chairman, Principal, Vice Principal, Dean, Staff members and Hostel wardens.

To create an awareness about ragging and the punitive measures that would be taken against students who indulge in the activity, a meeting was held at the seminar hall separately for various section of students and for hostellers too.

The students were told that the ragging has several aspects like psychological, social, Financial extortion, physical abuse, sexual abuse, verbal abuse, abuse through e-mails, blogs, public insults, passive participation in the discomfiture caused to others or any act that affects mental health and self confidence of the student would be treated as ragging.

It impeaches on fundamental right to human dignity. The punitive measures were read out to the students, it included submission of FIR by the institutional authorities with the local police authorities. It could also involve cancellation of admission, suspension of attending classes, withholding Scholarship, debarring from appearing in an examination and collective punishment and debarring from admission to any other institution.
